Call to Order

Beverly Sanders, Chair, called the meeting to order at 3:32 p.m. and the March minutes were approved.

Spring Break and Exam Schedules

- President Fuchs asked the council to look at the spring break and exam schedules after receiving a letter from a concerned parent. Should there be a policy?
 - Faculty Senate passed a request that spring break be the eighth week of the spring term.
 - Many instructors give students a choice if they wish to take the midterm before spring break for after.
 - o There doesn't seem to be any clear delineation what students prefer. Half want the midterm before spring break and the other have after.
 - o Susan Schaffer made a motion that there should be no university policy about when midterms should be given. Lauren Solberg seconded. The motion passed unanimously.

President Fuch's letter to student on teaching evaluations

- Beverly reminded the council that it requested that the President send out an email to students
 encouraging student to fill out the online teaching evaluations. Beverly talked to the President
 recently and he agreed.
 - Angel suggested that next year the council write a white paper on best practices encouraging students to complete course evaluations. Discussion will continue next year.

Student Honor Code violations and teaching evaluations

APC asked Welfare Council to review the honor code policy. Currently students who haven't
been to class or are in a holding pattern due to student conduct issues can still evaluate an

Council stated the department chairs have a way to handle bad evaluations and there is not a
need to continue discussion. APC discussion will continue next year.

Nicole Stedman asked the council to review the Kratzer Proclamation draft. Plans are for the senate to give Dr. Kratzer the proclamation at the May Senate meeting.

Susan Schaffer was elected as the APC chair for 2016-2017.
