Chris Hass, Chair of Welfare Council, called the meeting to order at 8:30 a.m. September 2014 minutes were approved.

**President's Council on Diversity Campus Climate Survey** – Jarrod Cruz-Stipsits, *International Engagement Director, University Minority Mentor Program Director,* Multicultural and Diversity Affairs

• Jarrod distributed an updated version of the draft climate survey on diversity. He noted that the survey is in Qualtrics and has two separate ones for staff and faculty. # SERU Data

Student Experience in Research University survey, which was started by UC Berkley, is taken every two years. According to Dr. Jeanna Mastrodicasa, Assistant Vice President for Student Affairs, students fill out up to 400 questions. UF data shows that our students study less than their peers, party more and attend class less. Chris will invite Dr. Mastrodicasa to a future meeting to give more data.

# **Internal vs External Tutoring**

The council was interested in why so many students prefer external tutoring instead of using the tutors available internally. Blake Murphy stated that more students use external tutors for large classes to help the student learn better.
