Intercollegiate Athletics Committee (IAC) Roles and Responsibilities

Appointment: By President via nominations

Chair: Appointed by Provost - Faculty who are not Athletic Representatives

Responsibilities:

- A. Recommend policy changes related to academic issues affecting or affected by intercollegiate athletics
- B. Monitoring of admissions and academic progress of all student-athletes
- C. Monitoring changes in NCAA and SEC rules and procedures relative to academic programs and progress
- D. Reviewing with the UAA compliance officer the institution's compliance program
- E. Receive, review and advise on various reports related to student athlete academic wellbeing (such as admissions, academic progress or others as identified by the committee or UAA
- F. Report to the faculty on issues related to intercollegiate athletics via the University Senate at least once per year
- G. Make additional recommendations to the President on any other matters related to academic issues affecting or affected by intercollegiate athletics

Definition:

• A member of the faculty; a liaison between athletics and the institution; and an official representative of the institution in NCAA affairs.

Guiding Principles:

- Ensure Balance Between Academic and Athletics
- Student-Athlete Well Being
- Advocate for Academic Integrity
- Institutional Control

Faculty Athletics Representative (FAR) UF Roles and Responsibilities

- Represent the institution and its faculty in the institution's relationships with the NCAA and the SEC
- Certify eligibility
- Serve on IAC and UAA Board of Directors
- Review NCAA Reports and serve as signature authority for NCAA Waivers



IAC Data Collection Two Important Metrics

GSR

- Graduation Success Rate
- Measures six year graduation rates at Division I institutions
- Includes transfers
- Excludes student-athletes who leave their institutions so long as they would have been academically eligible to compete had they remained

APR

- Academic Progress Rate
- Each student-athlete receiving athletically related financial aid earns:
 - One <u>retention point</u> for staying in school
 - One <u>eligibility point</u> for being academically eligible
- A team's total points are divided by points possible and then multiplied by one thousand



Academic Progress Rate APR Example

- A Division I Football Bowl Subdivision team awards 85 scholarships.
- If 80 student-athletes remain in school and academically eligible.
- Three remain in school but are academically ineligible and two drop out academically ineligible.
- The team earns 163 of 170 possible points for that term.
- Divide 163 by 170 and multiply by 1,000 to determine that the team's Academic Progress Rate for that term is 959.

Student Athlete Advisory Committee (SAAC) Responsibility and General Concerns

- Responsibility of SAAC: Address concerns directly or indirectly related to student-athlete welfare
- General understanding of conflicts associated with travel
 - o Test conflicts during finals week
 - o Faculty are not understanding of travel schedules
 - When at competition, assignments that are due online are not excused
 - When at competition, online assignments are not open in advance to allow for travel conflicts
 - o Group projects are challenging due to travel schedules
- Class timing
 - o Class times in major are late afternoons
