Faculty Senate Meeting Minutes March 20, 2014 3:00 – 5:00 p.m. Reitz Union Auditorium

Pradeep Kumar called the meeting to order at 3:04 p.m. February 2014 minutes were approved.

Chair's Report

Pradeep Kumar, Faculty Senate Chair-Elect

Provost's Report

Joe Glover, Provost

- Performance Funding
 - o The legislature is coming out with many proposals for performance funding.
 - Performance funding is when a governing body decides goals that universities are expected to achieve and if these goals are met the universities can share in a pot of money to use to further augment performance. If the goals are not met, then universities receive no money or are penalized.
- The Provost strongly endorses the move of the department of Economics from College of Business to the College of Liberal Arts & Sciences. Everyone involved is in favor.
- The Provost strongly endorses the restructuring of the Academic Personnel Board. This is a good move due to the large workload. Also, because of the many cultures on campus, restructuring will treat all cases fairly.
- Questions
 - David Groisser asked 1) what's changed since the performance funding was first presented at a past meeting and 2) If this law is passed and universities meet the benchmark, can the legislature deny funding to a university in the future?
 - (1) The Provost is thinks performance funding will most likely pass the legislature. The two chambers of the legislature have proposed different benchmarks and will have to decide which will be used.
 - (2) Once the law is passed, there will be a pot of money that will be available each year.

APB Restructuring

Angel Kwolek-Folland, Associate Provost Academic & Faculty Affairs

- Academic Personnel Board is fact finding and advisory to the President
 - Reviews promotion, tenure and permanent status candidates and makes recommendations to the President
 - o Board members read all packets usually about 225-250 per year
- President Machen proposes expansion of members on the APB and its division into work groups.
 - o Reconfiguration will not alter the consultative and fact-finding charge.
 - Expansion and division into work groups is to ease the workload and to provide for representation by wider set of faculty titles.
 - o SCORS and Welfare Council have reviewed the proposal.
- Suggested proposal:
 - Expand the APB from 6 to 10 members (plus the VP for Research)
 - Members would be either tenured full professors, distinguished professors or other faculty holding the most senior rank in the relevant title series, and would be appointed by the President.
 - Configuration
 - One working group would serve in a fact-finding and consultative role with regard to tenure and promotion of faculty in tenure-eligible positions (including distinguished professor awards). This group would be composed of tenured full professors or equivalent.
 - Second working group would serve in a fact-finding and consultative role with regard to permanent status and the promotion of faculty in tenure-eligible positions. This group would be composed of senior faculty in relevant title series.
- Questions
- David Groisser was having a hard time understanding how it's possible for the board to do a good job with such a large case load. Dr. Kowlek-Folland explained that each packet is submitted with a set of criteria to assist the board when it reviews the files. Sometimes the President goes against the recommendation of the APB.
- Paul Mueller (current member of APB) gave a short history about the board and noted that the APB does not have a policy role.

Provost Glover emphasized that the charge of the APB is to assure that the candidate
meets the University criteria. The Board is the President's advisory committee and
members are not on the Board to represent their college, department, or title series.
They are there to do their best assessment of whether or not the candidates are
meeting the university criteria and whether the college and department are aligned with
the university criteria.

Move Dept of Economics from WCBA to CLAS

Paul D'Anieri, Dean, CLAS

Angel Kwolek-Folland, Associate Provost

- Angel Kwolek-Folland updated the senate about what has happened since the senate agenda was posted.
 - University Curriculum Committee voted unanimously on Mar 18 to support the move.
 - o Graduate Council voted this afternoon unanimously to support the move.
 - The switch is to move the Deptment of Economics from the College of Business to the College of Liberal Arts and Sciences.
 - Economics department will stay in their own offices.
 - The students will be taught in the same classrooms.
 - There are no immediate plans to change the curriculum.
 - The support of the current graduate students will continue.
- Dean D'Anieri stated that he is excited and supports the move
 - The CLAS faculty council voted unanimously for the move.
 - CLAS chairs have no objections.

- Infrastructure Council encompasses the University's infrastructure supporting the University's academic mission, including the provision of physical facilities and other physical resources.

Open Discussion

- More discussion on the APB reorganization.
 - Sophia Accord asked why the two work groups are divided by title instead by work flow?
 - Provost Glover mentioned that part of the reason for reorganization is work load. The second motivation for reorganization is that the assignment of faculty and unit criteria varies across the university. One group most likely will concentrate on tenure issues and another will concentrate on non-tenure titles.
 - David Groisser was concerned about T & P candidates who think they are meeting the university criteria when the department and college agree, but the APB does not and then candidate is given a non-renewal notice.
 - Provost Glover reminded the Senate that the university uses a "tenure when ready" process. A faculty member may elect to go up for tenure before the maximum period. Once the process is started only the faculty member may stop the process. All entities can register input, with the APB attempting to answer if the faculty member met the university criteria. If everyone is in agreement, typically the case goes quickly. If a flag is raised, the APB takes a careful and independent look at all the opinions before giving an opinion to the President. The President reads the packet and takes all the data and opinions into consideration before making a decision.
 - Dr. Kowlek-Folland added that it is unusual for a packet to go through with everyone's agreement.
 - Edith Kaan asked the Provost about two items in the news that did not show UF in a good light.
 - Sudden resignation of the Director of UF Online after months on the job.
 - The Provost responded that after a national search, UF recruited Betty Phillips as Executive Director. Dr. Phillips' main interest lies in research into adaptive learning and personalized learning. As she worked here, she found that she was not going to be able to devote as much time on that passion. She decided to resign and returned to her previous university as a faculty member to continue her research.
 - Cancellation of the search for the Dean of the Law School.
 - Dr. Glover explained that the law profession is changing rapidly due to technology and globalization. The profession is diminishing and applications have dropped. The President didn't think that the three candidates were ideally suited to lead the College of Law through this turbulent time. The search will most likely be reopened in the fall.
