Rationale Please explain the rationale for the requested change.
Response: The FLL (Foreign Languages and Literature) major is a multi-track major. Students can major in one area track (e.g., German, French) but are expected and encouraged to take courses in other tracks as well. In practice, the existing prerequisites limited the course to only Japanese track majors and excluded others. This change is designed to make the course more accessible to

other students on different tracks in the FLL major. The course focuses on early modern Japanese literature. It takes an in-depth look at important authors and texts during this period. Students analyze these early modern texts and conduct meaningful research on them. All readings are in English; no knowledge of Japanese is required and thus no Japanese courses are needed as prereqs. Students with Sophomore standing are in a good position to take this course.
