 - Comments:
 - Just one minor point of clarification/no need for response: STA 4241 is not a “critical” tracking course but, rather, an upper division tracking course. Unlike the upper division tracking courses, critical tracking courses are those typically in Semesters 1-4 that are accompanied by a GPA requirement and penalty if the GPA minimum is not maintained.
 - Another minor point: PHZ3152 is not included in the course listing in the undergraduate catalog.
 - Just a comment: This is a well-prepared submission! I anticipate these changes will facilitate transfer students, along with the mentioned change/add major requests.

 - The sequence MAA4211 & MAA4103 is added as an option in the Additional Required Coursework for B. A.
 - The sequence MAA4211 & MAA4402 is added as an option in the Additional Required Coursework for B. A.
 - Additional Required Coursework: Added note for MAA4211 & MAA4402 option: If this option is selected, then MAA4402 (or MAA5404) cannot be used to satisfy the mathematics elective requirement.
 - NOTE: This request also includes a change to the upper division tracking requirements in Semester 7 with the addition of MAA4211.
- Comments:
 - MAA 4211 and MAA 4402 are not in the semester plan, yet this document lists those two courses as options for completing the degree. Need to be clarified.
 - Need an uploaded and updated semester plan to reflect these two courses.
 - [Currently, students in the MAT BA track have the option of choosing one of the following sequences:
 - (MAA4102-MAA4103) or (MAA4211-MAA4212) or (MAA4211-MAA4103). The current model semester plan includes only the sequence MAA4102-MAA4103 as a suggested sequence. If the requested change is approved, then students will be able to choose a fourth sequence, MAA4211-MAA4402, instead of the three listed above.
 - 1) Since we don't include any of the two alternative sequences (MAA4211-MAA4212) or (MAA4211-MAA4103) currently allowed in the model semester plan, I believe that it would be confusing to students to include MAA4211-MAA4402 in the model semester plan.
 - 2) Allowing the sequence (MAA4211-MAA4402) will provide more flexibility but it not more preferred than the other sequences not listed in the current semester plan.

- 3) Our majors typically complete the prerequisites for MAA4402 in the first two years and most of them complete MAA4402 earlier than MAA4211 or MAA4102. There is no particular reason, though, for MAA4402 to be completed during a specific semester and included in the semester plan.
- 4) However, MAA4102 appears in critical tracking Semester 7 so I have attached here (and uploaded in the course approval system) a change to allow MAA4102 or MAA4211 to fulfill that critical tracking requirement as this is our intention. Email, 3/9/22]

As, such STA 3100 was removed as prerequisite to other 4000 level courses that have as a mandatory requirement STA 4210, e.g. STA 4211, 4241, 4273, 4853, etc. It is also

the only prerequisite to STA 3180 – Statistical modeling. It is also planned to be added as a prerequisite to core course STA 4504, as its prerequisites have a path that does not require STA 4210...although it is encouraged for students to take STA 4210 first. Email, 3/9/22]

 - Create a zero-credit music ensemble that would allow upper division and graduate students who have completed the ensemble requirements or elective requirements for this degree programs the ability to continue participation in music ensembles without incurring credit limit or excess hours restrictions.
Note that, if the student is not enrolled in any other course, by state law, they will need to pay for 1-credit-hour of tuition and fees if enrolled for zero-credit hours.
 - Joint courses may only be 4000 level for undergraduate courses.
 - Request #17039 establishes a new graduate course, MUN 6013, for the same purpose for graduate students. This is pending at the Graduate Curriculum Committee.

Below is the description of the difference between expectations of graduate and undergraduate students. Please show how the additional expectations of graduate students will be reflected in how these students' grades are assessed. For example, will the instructor assess the participation of these students differently than undergraduate students, including a grade on their facilitation of discussions?

Undergraduate and graduate students complete the same assignments (primarily weekly lab exercises and a course project), but with respect to the course project (and associated milestone assignments) are **graded with different expectations**. Whereas graduate students are encouraged and expected to **work with their own data**, undergraduates aided in finding material for their projects.

In addition, **graduate students are responsible for facilitating a proportional share of the class discussions** (depending on enrollment). In addition to walking everyone through their solution to the assigned lab exercise, the facilitator emphasizes how the application of this particular technique solved the specific research problem at hand, as well as outlining the limitations and appropriate uses of such analysis. Graduate students are encouraged but not required to relate this to their own research and/or to add analogous examples related to their own interests.
