 - ~~What is the pedagogical rationale for the change in courses offered between semesters?~~ **We are swapping the location of ENV4601, Environmental Resources Management, and a tech elective in the model curriculum for administrative reasons. There will be no impact on the curriculum or students. Both of these courses occur in the senior year.**

With the change, ENV4601 moves from spring to fall and the tech elective moves from fall to spring. Tech electives have no prereqs. The prereq for ENV4601 is ENV3001, which the students take at least a year before ENV4601 according to the model semester plan. ENV4601 could be taken in either fall or spring of the senior year, but since we only teach it once a year we want to update the model semester plan to match our current teaching plan. - If ENV4601 is offered only in the fall semester now, how does the program handle a situation in which a student could graduate in the spring or summer and needs ENV4601 to graduate? Is there an acceptable substitute for ENV4601 that would prevent a student from having to wait until the following fall semester to graduate?

8. Modification of the BS in Materials Science and Engineering in the Herbert Wertheim College of Engineering [R][CA]

 - ~~What is the pedagogical rationale for the change in courses offered between semesters?~~ In 2019, the department decided to switch EMA 4121 to the Fall because of the way in which we offered the prerequisite courses. When previously offering EMA 4121 in Spring of their senior year, they noticed that students were having a difficult time in EMA 4121 due the extended amount of time that they had to wait to take EMA 4121 after taking the prerequisite coursework. EMA 4121 requires junior year courses: EMA 3050 (Fall), EMA 3066 (Fall), and EMA 3413 (Spring). By the time students took EMA 4121 in the Spring of their senior year, several semesters had passed, which negatively impacted the student's retention of the material. The instructors found themselves spending unexpected time on refreshing students on previously learned content. By moving EMA 4121 to Fall, it lessened the break time between EMA 4121 and its prerequisite courses and allowed for a better flow of course content. Now, instructors are able to optimize their time by building on previous knowledge and teaching new and more advanced course content, rather than spending time refreshing students.  - The list of submitted courses in this specialization is listed as “HSC4191.” Shouldn’t this course be listed as “HSA4191”?

 - Very oddly, however, this site lists the course with an “HSC” prefix: https://catalog.ufl.edu/UGRD/courses/health_science/

It would not be possible to get the same outcome, and certainly not within 120 credits. Our existing programs focus on traditional proficiency in Western classical forms and have an audition process that expects this proficiency. We have no programs that focus on and incorporate coursework in Music Business/Entrepreneurship, which is not identical to what is taught in Business. This program not only will open our doors to students interested in and with proficiency in commercial/popular forms, it will allow those students to gain the unique skills and learning outcomes needed to be successful in their transition to the professional world. Why is this degree program surplus to what we already have? We truly do not have an existing combination of programs that would allow students to realize the learning outcomes of this program.~~
- ~~What level of musical skill/proficiency is required for admission? The ability to participate in at least some of our ensembles.~~
 The ability to participate in at least some of our ensembles. As described in the first paragraph of section IV. Curriculum, applicants will demonstrate musical proficiency in 1) performance skills appropriate to participation in music ensembles, and 2) music literacy and musicianship skills necessary for core courses in music theory, aural skills, and keyboard skills. The Audition Assessment form can be found in Appendix N.
- ~~Given that the music forms will focus on commercial music, will hip-hop be included, and does UF have faculty with this expertise needed to conduct the audition portion of the admissions process? I'm sure the answer is 'yes', but I don't know for sure! Jen to check on this explicitly, but I believe the answer is yes.~~
 Yes, Hip-Hop is among commercial music styles that students will engage, in both Music Business coursework (Digital Musicianship and Production, for example) and in Commercial Music Ensemble. Primary faculty members associated with this program, José Ruiz and Scott Wilson, are both experienced in the performance, recording, engineering, and production of Hip-Hop music. In addition, a roster of

industry professionals, including Hip Hop artists, will contribute to the program.

 - Could more information please be provided regarding the rationale for the grade assignment and the desired purpose. The current grading system appears to possibly disadvantage students.
 - *Division between A and A- :*
 - *The division between the lowest A and the highest A- occurs in students who averaged overall score 87.5 +/- 2.5. As it is*

undesirable to have a student with 87.49 obtain a different grade from a student with 87.51, instead of having a hard boundary at 87.5, the students are first sorted in decreasing order of overall points and the division occurs at the largest gap (difference). So, if there are five students with overall points 89.6, 88.4, 87.3, 85.2, and 85.1, 87.3 is assigned the lowest A and 85.2 the highest A-.

- *Divisions between lower grades are decided in the same manner, with one exception. A minimum of 50% overall points is required for a student to earn a C.*

- ~~What is being removed from the course, i.e. objectives, content, assignments...?~~ This course was originally heavily focused on ruminant reproduction and consequently an additional credit (4 total) of laboratory time included rectal palpation of cattle throughout the entirety of the semester. Although palpation is an important skill, the course credit change reflects a restructuring of the curriculum to include a more diverse number of species and experiential opportunities that provide students with additional learning opportunities at various animal handling units rather than continuous practice of a single skill (palpation). As such, the shift from 4 to 3 credits reflects the removal of 1 credit of continuous palpation and instead incorporates more diverse laboratory and animal species. The learning objectives and assignments have been restructured to appropriately reflect the curriculum and to provide students with unique opportunities that are rare given current animal unit reduction approaches at many land grant universities.
