~~The approval form entry states that few students are expected to follow this new specialization. Given the effort and resources needed to create and sustain specializations across multiple offices on campus, would a more efficient approach be to allow students to pursue an existing specialization while selecting elective coursework in the focus areas (AI, reproduction, animal behavior, environmental science, etc.)? For example, the animal Biology specialization has ~38 credits of electives that students begin taking in Semester 1. We now believe that this new specialization will be chosen by many students because of the flexibility it offers and the current specializations by their nature and history do not provide a good home for these students. The Equine and Food Animal specializations are species or meats focused and the general expectation from the faculty that teach most of the courses in these specializations is that students look for jobs in the primary livestock industries. The Animal Biology specialization has a strong pre-health focus, for example requiring lots of chemistry to prepare students for application to veterinary school. Because selection of courses in the new specialization will be all advisor approved, we are now working on short lists of courses. We are doing this in consultation with the College.~~

If they fail a second time, they will work in consultation with the Academic Advisor to choose an appropriate class to fill the knowledge gap.**
 - Connecting students to UF Student Success academic support services is strongly recommended at the point of first failure to ensure they have ample resources to prepare for the exam retake. **Excellent recommendation. We will incorporate that into the process.**
 - Can more detail be provided as to why this exam is necessary? What percentage of students have not been prepared for upper-level coursework, e.g.? **According to faculty estimations, approximately 25% of students were lacking a few basics of plant science (photosynthesis, plant cell structure, etc.) upon entry to their Junior year. The Plant Science-Horticultural Sciences Merger Committee discussed creating an additional 2000 level course to try to address this, but landed on preferring mini-modules to catch small gaps in knowledge, rather than requiring additional courses, to allow more space for students to pursue training in their focal topics of interest.**
 - Who will design the exam, and how will it be assessed for its ability to accurately capture the students' body of required knowledge? **The exam is being designed by the Plant Science-Horticultural Sciences Merger Committee and faculty from PLS3004C (Principles of Plant Science), to ensure that the knowledge gaps identified by faculty are addressed. The relationship between exam success and class success will be assessed, and the exam will be adapted if necessary.**
 - Will the modules be available to students prior to their taking the exam for the first time? How aware of the exam content will the students be prior to their first take? How will the program prepare students to do their best on the exam in its first take? **Thank you for these thoughtful questions! Since this is basic knowledge they should have by junior year, the plan was not to create a large preparatory process, instead identify students with gaps and help them catch up. However, it does make sense to share the teaching modules ahead of time, so students unsure of their foundations can study ahead of time, so I will incorporate that into the process.**

- Will advisors oversee administration of the exam, or will faculty? How will the program ensure academic integrity? The PLS 3004C faculty will oversee the exam, with support from the Program Director and Academic Advisor.
- When will the exam be administered, and will a student be allowed to enroll in courses prior to their passing the exam? After consultation with the Committee and Faculty teaching PLS 3004C, the exam will be required as part of that course, taken at the beginning of the semester through the course Canvas site. PLS 3004C is already offered online Spring and Fall semesters, and is a requirement for Junior year, thus results from the exam will be early enough to allow time for students to take additional coursework before graduation, if necessary. Passing the exam will not impact ability to register for courses of the major, but if they fail the exam twice, the Program Director and Academic Advisor will work with the student to identify the appropriate course to fill the gap.
- Does the program have any data that might assist in predicting student pass rate on the exam and whether specific populations of students might need additional support prior to their first attempt? Unfortunately, those data are not yet collected, but the relationship between the exam and course grades will be assessed each year, to identify patterns and opportunities to offer additional support as needed.
- What is the plan to revise the exam as the program learns more about the effectiveness of capturing students' knowledge and as course content changes over time? We do anticipate the need for adaptation, and the Program Director and the Plant Science Steering Committee will assess the exam's utility every semester for the first year, then yearly thereafter.

- How are “high impact practices” selected, and how will students know what practices are acceptable? The list will be shared with students by the Academic Advisor, and online on the UF Plant Science Website. - Associate Provost Response: In reality, the 60-day requirement applies to a reasonable time period for make-up of final exams. Many instructors had been requiring students to take a missed final in the following semester (or even year) with future classes, and that is unacceptable. I am interpreting the Review Subcommittee's comment above as attempting to meet the spirit of the 60-day requirement, giving both instructor and student reasonable time to resolve any grade dispute concerns. I think it is reasonable to encourage students to come to you within 48 hours after receiving their exam grades to request explanation of grading while, at the same time, not refusing to meet with students who do dispute a grade of an exam after the 48-hour period. A student should have the ability to dispute a grade of an exam at any point during the semester and of the final exam and course grade for a reasonable time after the semester has ended. To encourage the 48-hour time period of response, you may include in an assignment for them to review their exam responses, rework the questions they did not answer correctly, and come to you with any questions about grading within a specific period of time. Thank you.

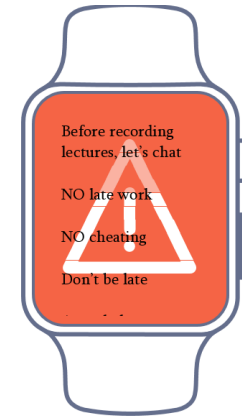

Rationale for using homework assignments

The class objective is teaching students how to write computer programs, how to analyze Earth science data, and how to conduct numerical modeling. All of these skills can only be acquired through practicing them (in addition to in-class lectures and discussions). Therefore the class is designed to include homework

programming assignments that provide students with opportunities to gain practical experience in coding, apply programming concepts, and receive feedback from the instructor, allowing them to develop a deeper understanding of programming. Using these assignments to assess students performance ensures that students will spend time and effort on completing them.

In addition, I think programming assignments are a better choice than exams because they can more closely mirror real-world programming tasks, where the focus is on solving complex problems through coding. In contrast, exams focus more on memorization and recall of programming concepts, which may not reflect the skills required for success in the workplace. The homework assignments also require students to design and implement their own solutions to coding problems, allowing them to exercise their creativity and apply programming concepts in new and innovative ways.

The main challenges for ensuring academic integrity when using programming assignments to determine grades I see are (1) making sure that students do not copy from each other; (2) making sure that students do not use automatic code generation tools. Since the assignments are very specific and unique to the course, students can not simply find solutions to these programming exercises online (and using online resources that provide basic solutions that then still need to be applied to the specific problem posed in the assignment is in fact a useful strategy to complete the assignments).

Therefore, I will use the following Strategies to help ensure academic integrity

1. Clearly defined expectations: At the beginning of the semester, I clearly define what constitutes academic misconduct in my class, including plagiarism, cheating, and collaborating without permission. I will emphasize the benefits of honest work, encourage students to value academic integrity and make it clear that I take this topic seriously. In addition, I will encourage open communication with students, including regular office hours where students can ask questions and discuss their work, allowing me to identify and address issues related to academic integrity early on.
2. Unique and challenging assignments: The homework assignments are unique and challenging programming problems that require creativity and critical thinking to apply the concepts taught in class. This will make it difficult for students to find pre-existing solutions, including those that may have been generated by ChatGPT or other code generation tools.
3. Plagiarism detection: I will use plagiarism detection software to detect code that may have been automatically generated. There are plagiarism detection tools available, such as Moss, that can help identify similarities between students' code and code found online, including code generated by AI models. In addition, each assignment has clear instructions and requirements, including details on code structure and algorithms. This will make it easier to detect code that deviates from the guidelines or appears to have been automatically generated.

Since there are many different ways to complete a given assignment, no two solutions that students have come up with independently would be the same, making it obvious when students copy from each other. That being said, detecting code that has been generated by AI models will likely remain a challenge for all programming classes in the future.

4. Monitor students' progress: I will have in-class discussions about the assignments and their solutions, which allows me to monitor students' progress throughout the semester, including their ability to explain their code. This will make it easier to identify students who are relying on automated tools or help of others to complete their assignments.
