# University Curriculum Committee Annual Report 2022-2023

The University Curriculum Committee is a university committee, governed by Senate Bylaw 20(A)(2)(b) which results in the following operational rules.

**Appointment:** The President or the President's designee shall appoint 12 voting members from the majority of baccalaureate degree-granting colleges within the University. The Senate shall elect 12 voting members from the faculty at large. Student Government shall select two non-voting members.

<u>Chair:</u> A chair is appointed by the President or the President's designee. A co-chair who shall have the right to vote shall be elected by and from the Committee Senate representatives.

**<u>Responsibilities</u>**: Committee shall consider all requests for changes in undergraduate curricula or catalog listings, and for the Bylaws of the Faculty Senate Bylaw 20(A)(2)(b) addition of new undergraduate courses of instruction in any of the colleges, divisions and schools of the University, except the Graduate School.

### Term: 3 years

<u>Meetings:</u> 3rd Tuesday, at 1:00 PM, in Reitz Union Senate Chambers. No meetings during summer semester. Supplemental meetings as needed.
