    - o Aligning Agricultural Operations Management degree with common prerequisites. From application: Agricultural Operations Management (AOM) is a technical management degree that has roots in mechanized agriculture dating back before World War II. While the curriculum includes hands-on training using applied technology through projects, labs, and field work it has a strong business foundation and emphasizes management skills and the goal of the program is to prepare AOM students to solve complex, interrelated problems in agriculture and natural systems. The business foundation of the AOM degree is well recognized within UF and in the wider business community that employs AOM students and many other programs like AOM are closely aligned with Agricultural or Resource Economics programs which are classified under CIP Code 01.0103. Although AOM has strong foundations in business, the program stresses the importance of technical science coursework including chemistry, biology, and physics which differentiate the program from the social-science weighted courseload in FRE. As a result, we request a separate track that reflects the program.

- If evaluating correctly, CGS2531, included on the revised semester plan, is not currently required. If this is correct, please notify CISE of the additional enrollments they should anticipate in this course.

- Reinstatement of a Minimum Course Grade Requirement for APK 3110C: Physiology of Training and Exercise in the College of Health and Human Performance. [CA][A]

    - o Request to reinstate minimum grade of C requirement for APK 3110C
  - Comments:
    - Is it known when or how this removal occurred? We are unsure when or how this occurred. In the spring of 2023, one of our academic advisors was meeting with a student and realized that they had earned less than a C in the course but were still able to register for another course that they should not have been able to register for. So, this was discovered in late spring 2023. Accordingly, this item was the first thing on our fall 2023 undergrad curriculum committee agenda. Removal of the minimum grade of C was never requested by our department. Email update, 11/13/23.
    - Has this C or better requirement been enforced in the years since it was removed?
    - What are the anticipated impacts on students? This particular course is foundational in our major, which is why we have historically kept a C grade minimum as a requirement on it. In our academic assessment plan curriculum map, every single one of our student learning objectives for the program is introduced in this course. Ensuring students earn a passing grade with decent proficiency is a benefit to ensuring they have what they need to excel in our upper division coursework. Since discovering the minimum grade requirement was not present, only a few students have been discovered to have earned less than a C. This is a typical number...as our academic advisor

reports that each semester, 0-3 students earn less than a C in APK 3110c. These students were contacted in time to either repeat the course prior to registering for courses that this serves as a pre-requisite for...or assisted in finding a new major. See last response for further explanation...

- What are the performance projections for students, and will this impact time to graduation (I.e. looking at student performance for last five years). To date, this has not impacted time to graduation for any of our students.
- Are there any remediation options available, or proactive measures to assist students that will be impacted by this minimum C requirement? This is a tracking course for APK undergrads. For students to remain in our major, they must have successfully completed all tracking requirements by the end of semester 5. Each semester, our academic advisor runs a report of grades to see if anyone has earned less than a C in APK 3110c—as this would mean students were "off track." If they have taken the course IN semester 5 and did not earn the grade minimum of C, then the students are contacted by our advising team and the student is assisted in finding a new major. Students are allowed to petition to stay in the major and complete the course in semester 6, but they typically wish to change majors. If the students take this course PRIOR to semester 5 and don't earn the grade minimum of C, then they are contacted and asked to retake the course and earn a C or better so that they are "on track" by the end of semester 5. If they don't want to retake the course, advising assists them in finding a new major. Because we run this report each semester to track grades, no students have actually made it into an upper division course that did not earn a C or higher in APK 3110c.

  - Please provide more information regarding this course and the PEN 2138C course. The current rationale for this course is not clear. PEN2xxxC Science Diver is an additional Scuba certification after a student has either taken PEN2138C or has the prerequisite NAUI Advanced Open Water Scuba Diver

recreational certification that they would have earned in PEN2138C. By taking PEN2xxxC they can earn the additional AAUS professional certification for Science Diving by learning and demonstrating the practices of underwater sample collection. Email update, 11/11/23.

- Is this replacing the existing course, is this modifying the existing course, is this meant to be taken at the same time as Advanced Scuba Diving (per uploading supporting document? There are a couple courses in the scuba track after Advanced. Master Diver (PEN3139C) does not require Science Diver. Leadership 1 Training Assistant (PEN3135C) does require Science Diver as does PEN4145C.
- What is the degree of overlap with the existing PEN 2138C course?
  - What is different? Students can take Science Diver without being enrolled in the Adv Scuba course. It would need to be approved by us though as they would need to have the necessary certifications obtained during the Advanced course before they enroll.

    - Moved from October agenda.
    - Please clarify the differences between multiple syllabi since previous UCC review. The course has been taught as a pilot two times first in Summer 2022 and then in Spring 2023. The two syllabi were provided as an offering of what the course would look like in a 6 week vs. full term format. There is now a 3rd syllabus uploaded for UCC review, and this is the one that should be evaluated moving forward as it incorporates all feedback from UCC. Email, 11/13/23.
    - The course syllabi has 4941 level and the new course request form is stating 3941. What is the difference between this course and the existing GEB 4941 course? The course has been taught as 4941 in the absence of it's own course

number because it is an experiential learning internship style course. The difference between 4941 and the proposed 3941 is:

#### GEB4941

- Students find their own internships. In GEB3941 the students complete a microconsulting project to gain work experience.
- Students may be local or remote (they are on site wherever the internship is located). In GEB3941 students are located in Gainesville, FL.
- Students complete assignments related to their internship employer/site. In GEB3941 the assignments are the consulting work for the employer.
- Is the consulting work done in the classroom or is this in addition to class meeting times? The attendance and tardy penalties seem to be disproportionately harsh for a 3000 level course. Please be sure to clarify that students with excused absences will not be penalized.
  - Consulting work done outside of classroom in addition to class meeting times.
  - In syllabus, clarified excused absences not penalized.
- Students with excused absences must be afforded the opportunity to make up missed work including exams. Please include link to the official UF excused absence policy and be sure that course policy is in line with UF policy and clearly noted without conflicting detail for students.

   Link in syllabus and clearly noted no penalty for excused absences.
- Students may have an extended period of time to dispute grades under current UF policy. This may be up to 90 days after the assignment. Grade dispute removed from syllabus. University policy will be followed.
- Three absences resulting in failure appears to be overly punitive. More
  information provided in syllabus the experiential learning aspect of the course
  and attendance is vital to get the experience.

- It appears that 50% of the course grade is team based with 20% of the grade coming from other students.
  - What is the policy for students having group difficulty? Students can discuss with me if they are having extreme difficulty with their group members. I do want them to address the problems first so they learn to deal with conflict and difficult situations just like they might encounter at work.
  - Is there an individual student grade component in the team presentation?
     Yes. How students assess each other in their teams are individual points.
  - Please provide more detail regarding how the team assessment will be broken down. Fifty points are possible to obtain for the team presentation. Twenty points are possible to obtain based on how team members assess each other. Seventy points are possible.
  - How are students prepared to assess each other for grades?
  - In class, instructors discusses what it means to be a good team member, leadership, and the book extreme ownership. Students apply the concepts and best practices discussed for the team member assessment. They are also encouraged to read the book, Extreme Ownership.
  - Are rubrics provided to students?
  - Yes. The team assessment is in the syllabus.
  - What is the reasoning for 30% of the grade being individual based?
  - The focus of the course is a team consulting project and learning about working in teams, not individual exams or papers.
  - Please provide more detail regarding the SFRD sheet.
  - Sheet in syllabus with description.

- How will companies for students to work with be chosen?
- Either provided by me or students can choose. If students choose a company, it is vetted and approved by me based on the information they provide me about the company and a discussion with the team.

Like in the previous course, the new COM number will exist as a Ling elective in another department. So I am not looking to get numbering as both. Email, 11/11/23.
    - Align attendance policy with official UF Attendance policy, or provide a link to it. Syllabus states there are no "excused" days but UF Attendance policy lists a number of reasons an absence will be excused. This was a failure of wording on my part. The course DOES align with UF policy. The 3 extra days before it

affects your grade are for unexcused absences. I have cleaned up the wording below to reflect this:

- Your attendance and participation in class is significant to your success in the class. Attendance will be taken daily. If you come to class unprepared, you may be asked to leave and counted as absent for that class period.
- NOTE: In the rare case of class being canceled, you will likely be given an assignment to do instead. In order to receive credit for your attendance/participation grade for that day, you must submit that assign by Midnight on Canvas on the day it is due. Always check your email before class for updates from me.
- Correct course point total. It does not equal the sum of the individual assignments (100+150+75+100+100+100=625; but syllabus says total = 600).

Students are required to purchase two books, by Volk and Horn. I am working on an optional coursepack that will aggregate the remaining required readings, but they are also posted on Canvas.
- On weekly schedule of topics, why are some weeks are listed twice, and some 3 times? Are these school days that will be holidays, or no class meeting? I include some weeks with two days in the schedule to account for some holidays and/or 1 or 2 days of no class, no matter which semester the course is taught. I have attempted to provide a clearer schedule below by omitting the mention of holidays or no class.
- O Grading scheme as listed is unclear due to formatting. Please clarify % of total grade and # of points of each assessment. It doesn't seem like the written description matches the numbers above (e.g. midterm looks like 12% on the list but says 15% in the description below). I hope it is clearer when seen in a table format as below. I had adjusted the midterm to 12% so that the points added up properly, but forgot to change it in the description. I have adjusted it so they now match. Table provided.
- How many in class group work assignments are there during the semester?
   There are seven group work assignments
- Assessments seem extensive; why is this not submitted as a 4000-level course? I added more assessments at the request of the students to reduce the number of high-stakes assignments and spread out their point totals. This course has been offered several times and I haven't had complaints about the level of work.

Showcases how skill-building initiatives to promote MEAL life skills (mindfulness, empathy, altruism, and leadership) can empower people while producing healthier social systems. It also illustrates strategies to create supportive environments to promote personal growth, community engagement, and social justice.

- Please remove all reference to General Education in the new course request form and syllabus. If the course is intended to be General Education, it will need to go through a separate approval process after approval by the UCC.
  - Is this course intended to be a General Education or a Quest course. I deleted the few mentions of General Education in the syllabus. It is NOT a Quest course and I don't have any immediate plans to apply for it to be a gen ed course either.
- Make-up policy is not consistent with UF policy. E.g. final exam make-up, syllabus indicates instructor discretion will determine if make-up is allowed.
   I've revised my make-up policy to clarify how it is consistent with UF policy.
- There is a concern that makeup option for in-class activities could be penalizing for students with excused absences, as it sounds like the final exam will be longer. Make-up final exam may also be a different format (regularly scheduled final is 50 MCQs, make-up, per syllabus, may be essay exam). This does not align with UF policy, make-up exams must be in the same format as original exam. The single essay question students will answer if they have any excused absences that fell on attendance/group project days will be very short. All students complete my basic multiple choice final exam with lots of time to spare in a 2 hour exam block. All students, whether or not they write the short essay, will take the 50 Q multiple choice exam.
  - Syllabus says all papers and reports must be submitted on time and late submissions for any reason will be penalized. Updated
- How many in-class activities will there be? If total is 100 points and they are worth 10 or 20, will the number vary each semester? For this syllabus it refers to 150 points and I corrected the UCC form to be consistent. The number of items can vary by semester.
- Note #2 in the syllabus is confusing; is this in addition to the prereq? Clarified in syllabus.
- Points listed in syllabus are different from points listed on UCC form (e.g. attendance/in class activities say 100 points on UCC form, 150 on syllabus).
