- 1. Updates from the Chair | Dr. Lindner
  - So far, we have not received an update on BOG guidance, which will be provided in response to SB266 as it pertains to General Education. This guidance is likely to come soon. The Communications Task Force has convened once so far to respond to the task of adding public speaking to all 11 GE communication courses. This task force is also exploring the possibility of adding this element to any GE course, potentially leading to badging or credentialling in the future. Faculty discipline committees have also convened to go over the new GE mandates, including those outlined in HB7. As all GE courses must be reviewed yearly to ensure compliance with SB266, this will be conducted on our campus using an online faculty self-audit. A Qualtrics survey will be coming soon for faculty to make comments and voice concerns. Dr. Lindner voiced her awareness of the increase in faculty responsibility that this self-audit creates, but hopes that this method will be the least burdensome. She will report monthly to this committee on the progress of the GE committees and progress made towards compliance. Finally, departments must continue to submit common prerequisite additions/revisions, as this is also required for compliance and is particularly important for our transfer students. We are striving for consistency and reliability. Compliance with all mandates will be expected in Fall 2024.

# University Curriculum Committee Program and Course Recommendations

- 4. The College of Medicine Requests a Combination Degree Program for a Bachelor of Science in Biochemistry -- Including Biology, Chemistry, IDS in Biochemistry, Microbiology and Cell Science, and Nutritional Sciences -- with the Master of Science in Biochemistry and Molecular Biology. [CA] [A]

- Summary:
- Create a combination degree program between the Bachelor of Science (B.S.) with a major in biochemistry-related programs including Biology, Chemistry, IDS in Biochemistry, Microbiology and Cell Science, and Nutritional Sciences, and the Master of Science (M.S.) with a major in Biochemistry and Molecular Biology.
- o 30 total credits, 12 academic (didactic) courses double counted for undergrad/grad.
- Comments:
- Is there a specific set of courses which may be double counted, or may not count, if so please list them specifically in the form. We did not list any specific courses that would double count. The reason is that we would like to have some flexibility on what we and the undergraduate advisor count towards both degrees because our cohort of students will have different undergraduate majors (Chemistry, Biology, Microbiology and Cell Science, and Nutritional Sciences). We anticipate that most students will take advanced courses from our Biochemistry and Molecular Biology concentration. Response, 10/13/23.
- This appears to allow for students to take all academic (not research) credits and fulfill all academic credit requirements for the graduate degree, is that the intent? This is a thesis-based BS/MS combined degree program and includes a research component. Students are allowed to double count 12 credits for the BS and MS degrees. We allow both academic (e.g. BCH5413) and research credits (e.g. Independent Research, BCH6905) to double count. This will be coordinated with the undergraduate major advisor. If the student takes all 12 academic/didactic credits as an

- undergraduate student, 18 research credits would have to be taken in the following year to satisfy the 30 credits required for the MS degree.
- Can transfer students be admitted, if so how would the transfer credit be evaluated? We will consider transfer students for admission to the combined degree program. We would coordinate this with the undergraduate advisor with respect to the credits that can count towards both BS and MS degrees.
- This request is well-prepared. Thank you!
- The external consultation memos state the following: Students who successfully complete their first year of the MS program may double count twelve (12) credit hours from the MS curriculum to satisfy the graduation requirement and be awarded the Bachelor of Science (BS) degree.
- What does this mean functionally? Are the 12 graduate credit hours taken by the undergraduate student not transferred to the graduate record until the student has successfully completed virtually all the remaining M.S. requirements?

- 1. What is the current availability of online courses through the academic year? I anticipated this question when I submitted the request. I listed those courses that are available in UF Online on the attached spreadsheet. Since course offerings can change, I did not want to signal the terms they will be taught in as this can change. The point is, there are enough courses available in UF Online that students who stay in UF Online vs. PaCE can earn the minor.
- Comment: many of the courses on the list of available courses for UF Online students are 1xxx-and 2xxx-level. This is a reminder that, per UF policy, at least 3 of the courses must be 3xxx-level of higher and none of these individual study courses. Fewer than 3 of the total credit hours can be satisfied with individual work.

- How does participation rubric work in conjunction with the discussion posts? Per syllabus, it appears they're combined for a discussion/participation grade and participation rubric doesn't account for the discussion. Separated the discussion post points from participation points. They are no longer combined. Response, 10/16/23.

- Will discussion rubric be added to the syllabus? Currently, only the paper rubric is included. I
  initially had the discussion rubric in the syllabus, but Word changed the format of the rubric,
  making it difficult to read. I've added the discussion rubric back to the syllabus.
- Syllabus is inconsistent re: the penalty for unexcused absences. UCC form and syllabus p. 2 say 4 unexcused absences are permitted, and beyond that a student's grade will drop from A to A-, etc. Syllabus attendance policy section on p. 6 says each unexcused absence will cause a grade to drop 10 points. These need to be reconciled/clarified. Removed the language on page 2 regarding the drop in student grades. Changed the number of absences from four to three. Retained the language on page six regarding the 10-point deduction for each unexcused absence. Re-uploaded the syllabus to my course request to reflect these changes.
