 - ~~Has the change for transfers from 7 to 6 courses already been approved and this is just a technical change in the catalog. This is simply an error in the count in the current catalog that we are correcting. Email, 1/9/24~~
 - ~~Do any of these changes need additional justification, e.g. the technical electives are now identified by course number (rather than any Physics course at 3000-level or above, for example)?~~
The following changes are included in the technical elective adjustments:
 - CISE, ECE, Mathematics, Statistics: rewording only; for ECE, rather than excluding most 3000 level courses, switched to an inclusive list.
 - Physics: there are non-Physics courses that are now listed in the Physics department catalog (e.g., cross-disciplinary laboratory). It was never the intention to include such courses, and they may not be classified correctly by an ABET acrceditors to meet requirements. As such, these are now being limited to PHY and PHZ. However, it should be 3000-level of higher; can I correct this? (That was the committee and college's intent.)

- CAP 3020 and CAP 3027 have been accepted as substitutions historically and have been reviewed for accreditation criteria. As such, the committee felt they should be included here.
- Capstone coursework and internships / cooperatives from other programs were excluded to ensure all internships meet CpE program expectations and requirements for accreditation.
- Practical Work limit of 3 credit hours has been policy and are a limit built-in to the course itself (maximum of 3 credits); this is just codifying it clearly in the catalog.
- Combined practical and independent study limits have always been policy; this is codifying this policy in the catalog. The justification is that, while it is important for students to have the opportunity to complete internships and independent study work, it is also important that such work not overtake education in subfields via recognized and reviewed general coursework.
- Previously, research, independent study, practical work, and outside coursework were addressed separately. The result was that, technically, some students could take just one (1) regular CpE technical elective, with all other courses being non-traditional or non-CpE coursework. The 9-credit cap ensures that at least 9 technical elective credits of regular coursework are completed as part of the degree program.
