The rationale includes:

1) Remove PSB 3002 from the Biology BA Distribution category Biology and Society as per Psychology department feedback that they do not have seats in the course to accommodate enrollment requests from Biology Majors.

2) Remove AGR 2332 Seeds of Change from the Biology BA Distribution category Biology and Society as it is a discontinued course in the Statewide Course Numbering System (SCNS).

3) Remove BSC 1920 First Year Introduction: Biology at UF from the model semester plan and the list of approved electives. The course is no longer being offered and has not been offered in several terms.

4) The Psychology Department does not have seats in their PSB courses to accommodate the number of Biology Majors requesting to take these courses as approved life science electives. Biology Majors requesting seats in these PSB courses are generally denied and told the seats are reserved for Psychology Majors. This feedback from Psychology Advising was also relayed to the CLAS Academic Advising Center.

Overall program goals will not be impacted because “this curriculum change to remove BSC 1920 and PSB courses from the elective list is requested for administrative purposes and only impacts the selection of approved life science electives available to Biology majors. In coming terms, the content areas covered in these courses may be fulfilled through offerings by other campus units.”

Changes were tracked in Catalogue and the noted approved electives were removed
