  - Establish a 9 credit certificate which will train students in the applications of artificial intelligence & data analytics in the tourism, hospitality and event industries. Students will learn about AI trends, analytic skills, machine learning concepts, technology applications, and issues in the industries. They will also have the opportunity to gain specialized knowledge and practices in areas such as spatial analyses, data mining and social data, smart tourism design in cities, attractions and theme parks.
- Comments:
  - LEI 4905 is an independent study course with a different way to compute contact hours than a traditional lecture-based course (see below). This has implications for how faculty maximum effort is computed.

Undergraduate individual study courses are managed by departments and

will continue to be manually entered and tracked. Departments are responsible for communicating course information to AAR Coordinators for entry into the AAR System.

Head count hours for individual study courses (course numbers: 4905, 6905, 6971, 7979, 7980) are calculated by dividing the contact total by 2 with the result being the head count contact hour for the course. For example, in section 7980, there are four students enrolled. The total contact hours for the section would be 2, or 0.5 per student.

- Comments:
  - Please provide more information/rationale regarding why the research components are being removed from the certificate. [A full program evaluation was completed following the graduation of the first cohort of the DRT professional students. The department critically examine the DRT program by collecting and analyzing information about the program's activities, characteristics, and outcomes. Data were collected from students, faculty and administrators directly involved in the program. The results allowed department administrators to make judgments about the program, improve its effectiveness, and inform programming decisions. Results from the evaluation indicated strong support for removing the research courses from the program. Data revealed that the curriculum provides adequate knowledge about evidence-based assessment techniques from the program without the need for training on conducting independent research. In other words, graduates of the DRT professional certificate are not required to conduct independent research, but rather identify and synthesize existing research. This is already accomplished within other program courses (OTH 6150 - Foundations, Models, and Theories in Driver Rehabilitation Therapy and OTH 6153 -Screening, Assessment, Evaluation, and **Intervention in Driver Rehabilitation Therapy).**]
  - "We are also increasing OTH 6155 On-site Skills and Competency Training and Testing in Driving Rehabilitation Therapy from 2 credits to 3 and reducing OTH 6156 Seminars in Driving Rehabilitation Therapy from 3 credits to 2." OTH6155 is listed on the certificate web site as 3 credit hours already (https://drt.ot.phhp.ufl.edu/prospective-students/curriculum/on-site-

<u>competency/</u>). Has the increase in credit requirement already been put into place (at least on the web site)? Is this course a variable credit course?

- Is OTH 6156 a variable credit course allowing a decrease to 2 credit hours for the certificate?
  - It does appear on the certificate's web site that these requested changes have already been publicized (<u>https://drt.ot.phhp.ufl.edu/prospective-students/curriculum/</u>). This seems to be prematurely advertising the certificate changes prior to approval by the UCC.

      - Answering a question or contributing to large class discussion
      - Contributing to small group discussions
      - Taking and submitting notes for small group discussion
      - Volunteering to participate in an "on-your-feet" activity (i.e., reading out loud from a scene, acting in an improvisation, stepping in as an audience member in a Forum Theatre scenario)
      - Responding to Canvas surveys about class progress and participation selfassessment

- Contributing to class discussion board on Canvas (sharing links, articles, videos that connect to class material) email, 5/3/21]
- Will the instructor assign one of the 3 topics submitted by students for each student's presentation? Same question for the playwright's paper and playwright's day. [Students have the opportunity in the first week of the semester to indicate their top three choices of presentation topic, as well as their top three choices of play/playwright. The instructor reviews the selections and then assigns one of the choices for the presentation and one for the play/playwright. (This has worked well so far each student has been able to present on their first or second choice). I see that I have this noted in the syllabus under 50 Playwrights, but not under the Presentation Assignment.]
- Read and Respond is worth 25% of grade; how much are each of the submissions worth? [There are a total of 13 R&R required. The first is worth 1%, with the remaining 12 worth 2% each, for a total of 25%.]
- Will group members be assigned the same grade on the final group project, or can group members receive different grades? [It is possible for group members to receive different grades on the final project, depending on how well their contribution fulfills the elements of the grading rubric.]
