## Welcome

Dr. Lindner welcomed new members and all members introduced themselves individually. Dr. Lindner provided a brief overview of expectations for committee members this year, which included reviewing the requests in advance of the meeting, representing their college, working with faculty on issues in advance of UCC meeting, and assisting submitters in their college.

Dr. Lindner also provided a rundown for items that the committee wants to achieve this year. The UCC aims to address faculty senate requests and complete creation of a Professional Curriculum Committee. New Quest 1 and 2 courses will continue to be proposed, and Quest 3 will be coming soon. Dr. Lindner also mentioned the President's wish to schedule a free day of classes in celebration of our new Top 5 status in the US News and World Report.

### 2. Election of UCC co-chair | Dr. Lindner

Dr. Lindner conducted the election. Dr. Vandana Baweja was open to serving. There were no other candidates or questions, and Dr. Baweja was elected.

### 3. Update on the creation of a Professional Curriculum Committee | Dr. Shorey

Dr. Shorey presented this item. In March 2021 a task force of representatives from different departments was assembled to discuss and outline the purpose and goals of the PCC. In April 2021 this task force learned how to use the UCC approval system. In June 2021 the task force had a walk-through meeting with Registrar's Office to learn about procedures and policies. In August 2021 work began to form the committee. Goals for the future include presentation for the Committee on Committees in October 2021, presentation for the Faculty Senate around April or May 2022, and finally nominations for members of the new PCC after all approvals are received.

### 4. Update from the Faculty Senate. | Dr. Lindner

The new proposed academic calendar will be presented to the Faculty Senate in upcoming weeks. The PDF proposal was shared with the UCC, but it will not be voted on today.

Scenario 1 has the spring term ending a week later and aligns Spring Break with Alachua County Public Schools. Local authorities have had objections based on not wanting high school and college students on break together. Accordingly, the alignment of spring breaks will no longer be considered.

Scenario 2 also provides an equal number of fall and spring days, but no longer includes the old requirement of 220 days. These two scenarios were presented to the Faculty Senate Steering Committee and Scenario 1 was dismissed. The Faculty Senate asked that Thanksgiving be made an entire week off for Fall, which necessitated moving the start of Fall up 2 days.

Santa Fe aligns their Spring Break with UF's, and this will be an ongoing discussion including the Alachua County School Board.

Dr. Lindner opened up the discussion. The reduction of days was not thought to be a reduction of MWF class days as they still have the same number of weeks. Hurricane days were previously accounted for as long as 220 days of course days was met but going forward it is thought likely that this would be accommodated for with Saturday classes. Faculty were cited as not having any issues with the new calendar model. Some students would need some assistance with their housing during the start of the later spring semester.

The second calendar question is more immediate. The president wants students to have a free day that no classes are taken. Initial conversation about holding it during this Fall semester, but the current thought is to have the free day in the Spring on Wednesday, February 9, 2022. This gives faculty enough time to work this day into their class plans. This

day will be a day of reflection on the importance of reaching the top 5, and also how UF will continue to be a top 5 institution.
