Comments: No catalog copy is provided – but we are not sure if that is required since NWSA majors do not appear in the catalog. I'm happy to provide catalog copy if needed. This has significant overlap with the existing minor. Are the courses of the existing minor not available at NWSA? Credits for this minor are 2 less than the UF minor – does that pose any concerns for COTA? Minor is different depending upon student's NWSA major? That is unusual. If approved as

Minor is different depending upon student's NWSA major? That is unusual. If approved as written, this will need two separate minor codes from the Registrar's Office to distinguish it from the UF minor. These are all a result of the NWSA curriculum being completely separate from the Gainesville curriculum, with separate instructors, courses offered, etc. The courses of the existing minor are not available at NWSA, and they would not be able to offer the existing minor with their faculty at that campus. This is also the reason that there is no concern from COTA or the SOM regarding differences between the minors, as they will serve completely separate student populations.

Syllabus also says any assignment submitted more than a week late will receive at least 50% point deduction.

Format of class section of syllabus says students need to check to see if there is class on Tuesdays, and from week to week the course schedule changes. Class is not scheduled for Tuesdays. Is this variable schedule consistent with College policy?

For assignment 6, does each team member receive the same grade for the assignment? Attendance policy needs to specify that excused absences will not be penalized.

Attendance policy not in compliance with UF policy – Needs to specify that each non excused absence will result in grade reduction (not any subsequent absences). Also, while documentation for medical excuse may be required, it cannot be required in exactly one week.

Office hours must be specific time/day.

Comments: Why does course have "Professor" and then another faculty member listed as "Assisted by"? Professor Grogan seems to have significant responsibility for the course.

Syllabus does not allow for any make-ups except in cases of emergency. Attendance/make-up policy for course needs to be brought in line with UF policy.

Syllabus states students only have 1 week to bring grading errors/questions to attention of course faculty – but grade petition policies allow for more time.

Syllabus mentions quizzes but on the list of assessments for the course, I do not see any quizzes listed. Also, course grading structure described in syllabus says 10 points for each module assignment, but some modules have 1 assessment and some have more than 1. Please clarify the grading scheme for the course and note point value for each assessment.

- Late work policy of grade reduction of 20% per day violates UF policy unless it applies only to unexcused reasons for late submission.
- No info in prior or proposed syllabus on the final project. Since this is a major reason for increasing the course level, additional information on the project would be helpful for the review.
- Topics and readings in the new, proposed syllabus appear the same (or nearly identical) to the 2000-level syllabus. There is explanation in the UCC form about differences between the versions of the courses but it's not clear how that translates into the new proposed syllabus. Is the literature reading table added to the last page of the syllabus in addition to what is listed on the weekly topic table? Note this may not be clear to students.
