  - Mr. Rose provided an overview of the new format for the UF Regulations and Policies website. The website name will be changed to [governance@ufl.edu](mailto:governance@ufl.edu)
  - The new website houses all UF regs and policies in one place instead of fragmented across several sites and units - more user-friendly and provides a consistent format
  - The regs and policies can be sorted by audience, category, and type
  - Includes histories of regs and policies and archived regs/policies
  - Includes information on development of regs by the Board of Governors and policy development by UF administration
  - Provides notice of new proposed policies and a method to subscribe to a listserv to receive the notices
