 Call to Order and Introductions - Alyson Adams, Committee on Committees Chair -The meeting was called to order at 11:30 a.m. by COC Chair Alyson Adams.

2. Approve March 29, 2021 Minutes

- The minutes were approved.

3. Update of the 2021 Committee on Committees Draft Report to the Faculty Senate Steering Committee

- <u>Lakes, Vegetation And Landscaping (LVL) Committee</u> Membership Increase Request – Gail Hansen De Chapman, LVL Chair

 Prior to COC's submission of its final report, the Chair of the LVL Committee requests consideration of an LVL Committee membership increase. The LVL Committee has discussed doubling their faculty membership from six to twelve. LVL has discussed and agreed that they favor a maximum of 12 faculty on the committee and a minimum of ten. The new membership would be evenly split (as it is now) between Provost-appointees and Senate-elected faculty.

 The LVL Chair actively recruits committee members, with an emphasis on nominating faculty with needed and specific expertise, which can be especially helpful during discussions which could be potentially contentious (such as opposition to tree removals, landscape design considerations, etc.)
-COC recommends that LVL develop an SOP or communicate to members why it is important to attend the meetings. Gail will consult with committee administrative liaison Linda Dixon, AICP, and Director of Planning, UF Planning, Design & Construction about writing one.

- Because LVL is a joint committee, it reports to the President; COC is able to make a recommendation but membership changes would not move forward without the support of the administration. COC approves LVL's request, contingent on agreement by this joint committee's administrative liaison, VP of Business Affairs, Curtis Reynolds. If so approved, this will be on the UCRC agenda in September.

- Pending items discussed included a brief update from COC member and Senate Officer Term Ad hoc Committee Chair Richard Scholtz. The latter last discussed improving the onboarding of all new committee and council chairs as well as the Faculty Senate Chair and Chair-elect. In addition to increased training for the Chair-elect, the committee recommends no immediate term changes for the Faculty Senate Chair. Other suggestions from the Ad hoc Committee which would be addressed by the University Constitution & Regulations Committee (UCRC) include: adding a Communications Officer to the Senate to conduct outreach to faculty and the Faculty Council/Assembly Chairs; instead of the Faculty Senate Chair-elect and the Faculty Senate Chair being the voting UF Faculty Senate representative to the Advisory Council of Faculty Senates (ACFS), the Faculty Senate Past Chair would be, to allow every UF Faculty Senate Chair two years of experience on the ACFS and to free up the Chairelect for additional training; and lastly, each Faculty Senate Past Chair should write a report at the end of his/her term to assist with the Chair transitions and to help determine the strength and success of the UF Faculty Senate voice on the Board of Trustees and the ACFS.

- Another pending item follow-up made by Chair Scholtz is that he is contacting the incoming Infrastructure Council Chair to stay in communication with the joint committees regarding how any possible countermanding shared governance decisions could be addressed. This item was added to the April Infrastructure Council agenda to help address communication between the Architectural Review Council and the (joint committee) Land Use and Facilities Planning Committee.
