## Law

- Is 25 hours of class time sufficient for 2 credits for College of Law? **Yes, 25 hours of class equal two credits for the Levin College of Law. The American Bar Association, the CoL's national accreditor defines the minimum needed for each credit hour as "...one hour of classroom or direct faculty instruction as fifty minutes under ABA Standard 310(b), Interpretation 310-1."** Each hour long credit is equivalent to 15 weeks of instruction or the equivalent amount of work over a different amount of time under Standard ABA Standard 310(b). 25 hours of class time is the equivalent of 2 credits under this standard.  $15 \times 50 \text{ minutes} \times 2 \text{ credits} = 1500 \text{ minutes}$ .  $1500/60 = 25 \text{ hours of class time}$ .
