Updates | Dr. Shorey

- Changes the UCC is suggesting for new courses (requiring a syllabus and changing questions in the Approval System).
 - The proposed change would require the submission of a syllabus with the new course request, aiming to streamline the review process.
 - A working group considered this change and will ask the PCC to either continue with the current process or to implement the new one in their next meeting in August.
 - How can we make it better removing the administrative burden.
- Reviving the subcommittees on the Professionalism and Catalog (due to the Registrar's Office new technology).
 - The implementation of the new catalog and curriculum management systems, Course Dog, would start in the fall, aiming to reduce the workload of maintaining a catalog and improve administrative efficiency.
 - There will be a vote on reviving the subcommittees for professionalism and catalog in the upcoming August meeting.

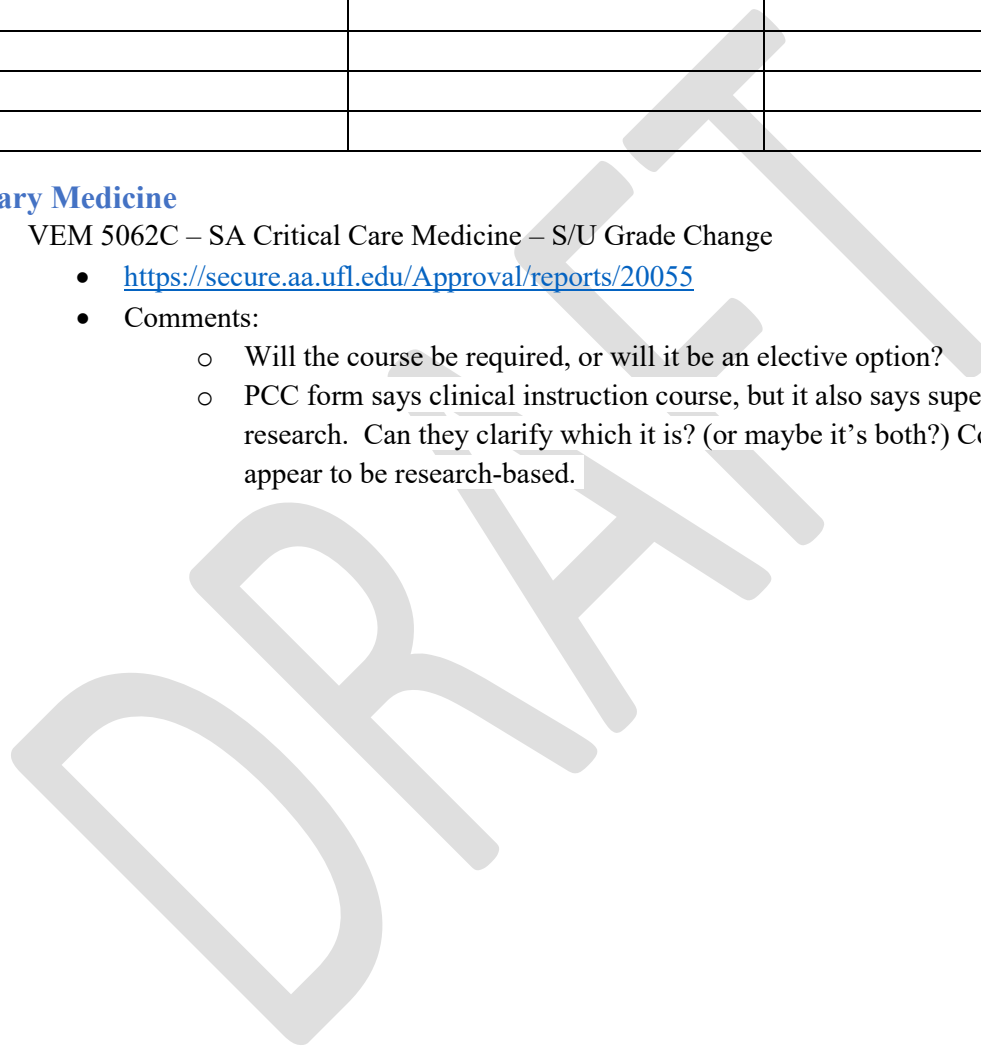
