 - ~~The Clinical Manual doesn't appear to have been updated to match the changes described in the submission form and course catalog. E.g. on page 23 of the Clinical Manual, the grades for Electives/Selectives don't have the same breakdown as at the end of the submission form.~~ My understanding is the Clinical Manual is being replaced with individual course syllabi. I believe the other course syllabi are being updated to a more appropriate format than the Clinical Manual but without any changes to title, LOs, current assessment methods, etc. PA program should confirm this is correct. I also suggest a bit of a "cleaner" version of the catalog copy since this is what will ultimately be fed into the new approval system and eventual catalog.
 - This is correct; instead of clinical manual, each clinical year course will have a separate syllabi which is more aligned with both University and accreditation standards; the assessment strategy (i.e. grade breakdown) is intentionally being changed to what is reflected in the new syllabi. The "Clinical Manual" is included to demonstrate the condition of elective course syllabi in years past. The approval of the 3 course modifications that are part of this project will update the elective syllabi. There are UF and ARC-PA (accreditation agency) compliant syllabi for other core/required courses. These courses are not being modified at this time.
 - The attached course catalogue has been updated – the one labeled "After Proposed Change," has been updated to reflect what the clinical year curriculum will look like after approval of this set of course changes.
 - We will submit requests in the future to retire elective courses that are no longer needed and modify any additional courses that have the "L" lab designation.

- The submission form indicates that the only prerequisite is successful completion of the first year of law school, but the syllabus says that Patent Law is a prereq (and it doesn't appear to be a required first year course, according to this: https://www.law.ufl.edu/academics/degree_programs/juris-doctor/degree-requirements) **Thankyou for catching that. I have updated the request.**
- The description of course grading does not include a breakdown by percentage of how much each assignment and participation contribute to the final grade. **I have updated the request.**
- The course attendance policy doesn't appear to accommodate absences due to illness. The absence policy must comply with UF attendance policies for any excused absences. Since this course will meet weekly, missing more than 3 sessions would be significant, even if for excused reasons. What happens if student misses 4 classes even if for excused reasons? **The student would be referred to the Office of Student Affairs to work with staff and the professor regarding the course.**

 - Course objectives could be stated more actively —e.g. “describe” rather than “be familiar with” or “understand”. They also probably shouldn't be framed as something that the instructor “hopes” the students will come away with.
 - Is the way participation will be handled consistent with other law courses? The idea that exemplary participation could bump a grade up and disruptive participation could take it down but it's otherwise not part of the total grade seems outside of the norm to me.
 - The final exam is described as being both take home and take in the exam period —which is it?
 - **It's a take home that students will do during the approx 2-week exam period. They decide when to pick it up and have some specified period of time to complete and submit it.**
 - Please updated attendance policy to comply with UF attendance policy. The attendance policy described in the syllabus doesn't seem entirely consistent with the college's attendance policies. For instance, the course instructor indicates that they do not distinguish between excused and unexcused absences, where as the college policy says students should be allowed a reasonable amount of time to makeup work if they are absent due to illness. Additionally, while the religious observance boilerplate is included later in the syllabus, the statement that excused

~~and unexcused absences are treated the same seems to contradict that.~~ I will ensure that future attendance policies are consistent with UF policies.

 - ~~Please clarify how the 1-credit course helps students reach full-time status during the summer. PCC form says students take a 3-credit summer course. Are they registered for other courses too?~~ Our DAT students take a required 3-credit course in Summer B (initial admission) and Summer A (end of 1st year). The 1-credit repeatable option is an elective/optional course that a student can add to their Summer B or Summer A load in addition to the required course to reach the 4-credit full-time status for financial aid assistance.
 - ~~Will students always register for this during a summer session or can they register in fall or spring semesters as well? There is only a 6-week list of topics and references to course holidays is July 4, among other indications this is summer only. The course is a summer only course, the schedule listed on the proposed syllabus is for Summer B 2025, the first semester we plan to offer it as an enrollment option. Our DAT students are full time (12-credit hours) in the Fall and Spring semesters for both year 1 and year 2 in the program. The optional 1-credit course provides an ATR prefix option for them to add (if needed) to summer term(s).~~
 - ~~What are some examples of the settings where students can complete this clinical experience?~~ Our DAT program offers students 1 of 4 concentration areas (Orthopedics, Manual Therapy, Teaching & Leadership, and Sport Performance). A student who added the 1-credit optional elective would complete clinical experience hours with one of our established preceptors or faculty members within their concentration area. The Manual Therapy concentration is embedded into the University Athletic Association Sport Performance Health, Sport Performance is embedded in the UAA Sport Performance Health and UFHealth OSMI Physical Therapy, Orthopedics Concentration is embedded within multiple clinics at OSMI, and Teaching & Leadership is embedded within the DAT/Department of APK.
 - ~~Meeting time/location is listed as period 4 on top of the syllabus, but syllabus also states meeting times/locations will be arranged between preceptor and student. Period 4 is listed as a place holder for scheduling. The required 3-credit course the student takes concurrent with the 1-credit elective meets periods 1-3.~~
 - ~~Is each critical thinking assessment worth the same number of points?~~ Yes
 - ~~Late submissions should be accepted for excused reasons.~~ They are and it's listed in the policies on the syllabus (under the Absence and Assignment Make-up Policy heading), in alignment with UF policies.

In the 3 syllabi there was a question as to what was meant by “Prioritize” when used in LOs about physical examination and diagnosis making. This verb was chosen to indicate a specific skill at a high level of Blooms Taxonomy (Analysis and Synthesis). Students have already demonstrated the ability to execute a head-to-toe physical exam and create a general differential diagnosis in previous course work. These learning outcomes are aimed at the advanced skill of selecting which exam skills or diagnostic testing should be “prioritized” when time is limited or the patient condition is more acute. It's intended as more a measure of the student selecting the right item to fit the needs of the patient encounter. – Happy to discuss further in person at the meeting.
