Law

Questions that emerged from Law course review. These are not causes for holding up the courses, but curious if the Law School has common policies for:

- ~~Course attendance policy~~ Per McIlhenny - **UF Law follows the academic standards policies set forth in Standard 308 (a) by our accreditor, The American Bar Association (ABA). "Standard 308. ACADEMIC STANDARDS (a) A law school shall adopt, publish, and adhere to sound academic standards, including those for regular class attendance, good standing, academic integrity, graduation, and dismissal."** This standard allows law schools and law professors leeway in determining how many classes a student may miss. For example, a class with 1 class meeting a week may allow fewer absences, except for religious holidays, than classes that meet 3-4 times a week.
- ~~Recording in class policy (I noted this — the law courses generally say class recordings are available if a student misses class for a health issue. What about an excused non-health reason? I initially put a comment for each course but the law school should address this broadly, and for each course submitted)~~ Per McIlhenny - **We can update all forthcoming syllabi for the Fall 2024 semester with our initial recording policy regarding mediasite and add a link to the University's recording policies page.**

Here is suggested wording from the UF syllabus policy page: In-Class Recording suggested wording (https://syllabus.ufl.edu/media/syllabusufledu/syllabi_policy_09_09_2022.pdf):

- **Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal educational use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor.**
A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and delivered by any instructor hired or appointed by the University, or by a guest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), field trips, private conversations between students in the class or between a student and the faculty or guest lecturer during a class session.

Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by

a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

- ~~Law school grading rubric for participation?~~ Per McIlhenny - ABA Standard 314 allows law professors to choose their own rubrics for assessing components. “Standard 314. ASSESSMENT OF STUDENT LEARNING A law school shall utilize both formative and summative assessment methods in its curriculum to measure and improve student learning and provide meaningful feedback to students. Interpretation 314-1 Formative assessment methods are measurements at different points during a particular course or at different points over the span of a student’s education that provide meaningful feedback to improve student learning. Summative assessment methods are measurements at the culmination of a particular course or at the culmination of any part of a student’s legal education that measure the degree of student learning. Interpretation 314-2 A law school need not apply multiple assessment methods in any particular course. Assessment methods are likely to be different from school to school. Law schools are not required by Standard 314 to use any particular assessment method.”
- Professionalism/Courtesy/Civility policy Per McIlhenny - UF Law teaches an entire, required course on Professional Responsibility; it is impossible to distill it into a short definition. Please see ABA Interpretation 303-5 “Professional identity focuses on what it means to be a lawyer and the special obligations lawyers have to their clients and society. The development of professional identity should involve an intentional exploration of the values, guiding principles, and well-being practices considered foundational to successful legal practice. Because developing a professional identity requires reflection and growth over time, students should have frequent opportunities for such development during each year of law school and in a variety of courses and co-curricular and professional development activities.”
- ~~Generation question re: LAW—~~ are they all 6000 level courses at COL? Per McIlhenny I started and then stopped noting this for each course – LAW course schedules seem to only be 13 weeks. Is there a reason they aren’t listed as 15 week semesters? Yes, UF Law’s courses are 13 weeks long. We also have weeklong, 1 credit courses held the week before the semester starts, called compressed courses. Two of our compressed courses, Intro to Immigration Clinic and Intro to the Prosecution Clinic, are listed below for permanent numbering. That is why the readings seem substantial. This is the only course the student takes during that week.

 - ~~What does this mean: Free speech is not an absolute right in an online course?~~ Per McIlhenny - I have edited this out. Thank you for pointing it out.
 - Does the highlighted NOT need to be removed? Students are expected to understand that this is **not** an online asynchronous course and that they will not have the same type of “face-to-face” synchronous contact with the professor. Of course, office hours can be arranged at request through Zoom.- Thank you. I have removed “not.”
 - ~~This is not in compliance with attendance policy: Late policy: Late submissions of quizzes will not be accepted for any reason. The very generous policy of~~

~~dropping the 5 lowest quiz grades (out of 10 quizzes total) was specifically intended to offset the fact that for various with or without excused reasons, students may not timely complete quizzes. The 5 lowest dropped quiz policy should cover all circumstances in which students cannot timely submit a quiz. Students are expected to manage this allowance wisely, including any foreseen professional or personal conflicts during the semester. Please do not submit requests for late submissions.~~ - Students are effectively permitted five absences. The approach outlined in the syllabus is consistent with ABA standard. Is the issue that the syllabus needs to provide that the policy on religious-holiday related absences will not be supplanted? We're not entirely sure what the issue is if that is not the problem.

- ~~I'm seeing an error on the TOC page at the top in place of one of the page #s. I have fixed this.~~
- ~~Note — the instructor is assigning his own textbook that he authored.~~ UF Law allows professors to assign textbooks they have authored.
- ~~Does each module run for generally 1 week or so? How does that work with 10 modules and 15 semester weeks?~~ UF Law has a 13 week semester. The ABA allows this so long as the number of ABA's requirement related to minutes per credit is met. The ABA provides in its interpretation of Standard 304: "If a law school on a semester system offers classes in units of 50 minutes per credit, it can provide 700 minutes of instruction in 14 classes. If such a law school offers classes in units of 55 minutes per class, it can provide 700 minutes of instruction in 13 classes. If such a law school offers classes in units of 75 minutes per class, it can provide 700 minutes of instruction in 10 classes." For this particular course, the professor sets the module length within his Canvas course.
- ~~Is the final exam proctored?~~ This exam is not proctored. The Law School does not require every exam to be proctored, but the Law School relies on exam software of a type commonly used in law schools to ensure verification of student identity. This is consistent with the ABA interpretation of Standard 306, which provides that verification of student identity may be established through "a secure login and pass code."
- Given that this is an online, asynchronous course, how can 2 absences be permitted? To what is this attendance/absences policy referring? And, any excused reasons for late submissions must be honored and students must be given the opportunity to submit quizzes/assignments late for excused reasons.

 - ~~Is 33% of grade being participation acceptable? Perhaps a rubric showing how participation is more than being in class?~~ Per McIlhenny - **Yes, 33% is acceptable. It is at the discretion of the instructor under ABA Standards. The instructor explains class participation is “engagement in class discussion and written work product.”**
 - ~~The three grading components add to 99%. Where is the extra 1%? I have adjusted this; there was a typo.~~
 - How is class participation assessed?
 - Only 13 weeks in the weekly schedule of topics.
 - ~~“At least” 6 reflection papers throughout the semester. Students should know the exact number to be required. Syllabus does not indicate when these will be due, nor does it indicate when other assignments are due throughout the semester. Professors routinely announce due dates through Canvas during the semester, rather than on the syllabus, and inform students of that. This is acceptable practice at UF Law and is consistent with ABA Standards. I have adjusted the language for number of papers required.~~
 - Attendance policy does not account for emergencies where instructor cannot be notified in advance. Note – the syllabus gives a link to undergrad catalog policy.

 - Only 13 days of class material included on UCC form and syllabus. Even with changes in course pacing from semester to semester, instructor should have identified the topics to be taught in the course; this should be provided in the syllabus with a general schedule.
 - Are class recordings available if a student misses class for an excused non-health reason?
 - How is participation assessed?
 - ~~Is there only 1 quiz or are there multiple quizzes throughout the semester? What is the value of each?~~ Per McIlhenny - **There is only one quiz given during the semester. It is valued at 15% of the grade, as indicated on the syllabus.**
 - ~~Please provide some info about the final paper assignment.~~ - **Students must draft a paper for their final assignment, which is 75% of their grade. Papers are often assigned in upper-level law school courses. Students are given the due date and suggested topics towards the beginning of the course. I have attached suggested topics from The Fall 2022 course to the current syllabus. Again, this is consistent with the ABA; the ABA explains in its interpretation of Standard 303 “Scholastic achievement of students shall be evaluated by examinations of suitable length and complexity, papers, projects, or by assessment of performances of students in the role of lawyers.”**

That statement simply suggests that students should not rely on this course as a substitute for a commercial bar exam course, which would be taken post-graduation in the weeks leading up to the bar exam. We don't want the students thinking they can skip the necessary preparation in the weeks before taking a state bar exam simply because they took this class. Passing a state bar exam is required to practice law; this course provides a valuable foundation for the students' preparation to take a bar exam after graduation. Professor Grossman does not push any particular commercial program in his course.**

Per McIlhenny - “Administrative law is a vast area of law; the course is generally structured at all law schools so as to provide both an overview of selected topics and provide in depth treatment of a smaller subset of topics. The main difference between a 3- and 4- credit version will be in the number of topics covered and in the depth to which the topics are discussed. For example, in the 4-credit version, the faculty member would be able to touch on issues relating to subdelegation by agencies and staffing by agencies, whereas the 3-credit version would not allocate reading to these topics. In addition, the 4-credit version is able to spend more time on topics such as judicial review and internal agency review processes. Under Standard 310, the ABA requires that each 1 hour of in-class instruction have associated with it a minimum of 2 hours of out-of-class individual study. Thus, an additional difference will be that students will be expected to spend approximately 42 hours in a semester on individual study outside of the classroom for the 3-credit version and approximately 56 hours per semester for the 4-credit version. The law school closely monitors for compliance with this ABA Standard. The length of the final exam will also be increased for the 4-credit versus the 3-credit version. Each professor has discretion when it comes to assessing grades, under ABA Standard 314. This assessment can be determined at the start of each semester. ABA Standard 314 allows law professors to choose their own rubrics for assessing components. “Standard 314. ASSESSMENT OF STUDENT LEARNING A law school shall utilize both formative and summative assessment methods in its curriculum to measure and improve student learning and provide meaningful feedback to students. Interpretation 314-1 Formative assessment methods are measurements at~~

different points during a particular course or at different points over the span of a student's education that provide meaningful feedback to improve student learning. Summative assessment methods are measurements at the culmination of a particular course or at the culmination of any part of a student's legal education that measure the degree of student learning. Interpretation 314-2 A law school need not apply multiple assessment methods in any particular course. Assessment methods are likely to be different from school to school. Law schools are not required by Standard 314 to use any particular assessment method."
