  - Since the course satisfies WR 2000 words, does the Experiential Learning Writing Assignment (700 words) count towards this requirement? If so, that should be stated.
  - There is no Argument Analysis Paper but the syllabus states that the in-class Essay Exam (30%) will fulfill the writing requirement.
