6. GEP Changes 2015, 2016. Dr. Mair summarized the GEP changes; statewide core changes are to be made in 2015 and UF core changes to be made in 2016, although they can be made sooner.
7. Proposed Gen Ed changes to Bachelors of Construction Management curriculum, effective Summer B 2015. Dr. Wehle presented. Recycled with a request to add a state core humanities requirement, and reduce the number of Composition courses to two.
8. Proposed revisions to the Bachelor of Landscape Architecture degree, effective Summer B 2015. Dr. Wehle presented. The proposal included a course, EVR X001, which may not be available for 2015. The GE courses should be removed from critical tracking. Recycled.

9. Proposal to change Visual Art Studies from a specialization to a major. The College of the Arts relayed that Visual Arts Studies has been a de facto major in the catalog for a very long time so Dr. Schaefer made the request to make this official. Approved.

Dr. Haddad presented a proposal to change from three departments to two and a desire to make this change official in Spring 2015. CALS raised an objection concerning a perceived naming overlap with Family, Youth and Community Sciences. Conditionally approved pending CALS and Nursing agreeing on names.
