

<p style="text-align: center;">Minutes of the Meeting of the University Curriculum Committee October 20, 2009</p>

Bernard Mair convened the UCC at 1:33 p.m. in 226 Tigert Hall.

1. Approval of minutes of September 15, 2009 meeting.

Dr Richard Lutz presented this item in Dr Ray's absence. The request was approved.

5. Proposal to Reinstate Minors in Entrepreneurship and Real Estate, effective Spring 2010.

Dr Lutz explained last year's discontinuation of the highly popular minors were a result of budget restrictions. The college now has funding for permanent faculty to teach the required courses. The reinstatement of both minors was approved.

6. Proposed revision to Actuarial Sciences Minor, effective Fall 2010.

Dr Walker King presented a revised degree plan for the Actuarial Sciences Minor. Due to credit hour changes in required courses (ECO2013 and ECO2023) and revised content in STA4210, STA4853 course is no longer needed to cover appropriate material in the minor. The revisions were approved.

7. Proposed revision to Family, Youth and Community Services major, effective Summer B 2010.

Dr Telg explained the proposal to expand the approved physical sciences courses. The revision was approved.

8. Proposed revision to minor in Organizational Leadership in Nonprofits, effective Spring 2010.

The committee had two main concerns with the proposed revisions. First, the documentation included a GPA requirement of 3.0, which the committee believes

is an increase. Second, the description included an international statement, but the courses do not imply an international aspect to the minor. The committee also recommended generalizing the description of colleges that may have interested students as it is not all inclusive. The proposal is being returned to the college for further clarification on these points.

9. Proposed elimination of Agronomy and Crop Science, Dairy Science, Poultry Science and Plant Pathology Bachelor of Science degree programs, effective Spring 2010.

Dr Telg explained that a degree has not been conferred in any of these programs in many years. Students have concentration options for this content in other degrees in the College of Agriculture. The elimination was approved.
