Dr. Knight presented this certificate request. 29-30 credit hours. Intended to benefit students who have developed expertise in econometrics and economic data analysis during their undergraduate studies. Both Economics major and minor allow flexibility in choosing electives, and many students have chosen to focus on this area. Certificate allows for a specific credential to show this focus. All courses are upper level, so several prerequisites are needed. One extra course would be needed outside of the Eco major, and three outside of minor requirements. Graduation plan would be required when applying for the certificate to show that time to graduation would not be increased.
Dr. Janelle asked if department anticipates any students from outside the Economics major to pursue this certificate, as it requires a large number of credit hours. Dr. Knight replied that they do anticipate students from the Economics minor, as well as possibly the FRE major from the College of Agricultural and Life Sciences.

Due to losing limited access status, Accounting will no longer be able to require all Critical Tracking courses to be taken at UF. The Finance major has never required this. Requiring Fisher School of Accounting Financial Accounting Competency Assessment with a minimum score of 70% will allow for students to assess themselves and see if they are ready for this course. Website will be created to help students prepare for exam. The exam will be administered via Canvas and will be open throughout the term. All FIN and ACT minors will be informed of this requirement, and information will be included in all documentation for transfer students. Honor Lock will be used to proctor. Student Group will be created to organize these students in the SIS and make sure they get the exam on Canvas. Three attempts will be allowed, students can petition for fourth attempt.

Dr. Shorey commented that the DRC should be brought on board to make sure that students who need accommodations are communicated with and served. Dr. Janelle commented that

communication could be sent to our fellow FL public schools to inform them what material is covered on this test, as many students take the ACG prerequisites outside of UF.

 1. Impact on Enrollment, Retention, and Graduation: “We do not expect enrollment in courses or the HEB major to be impacted by this change. Likewise, we do not expect retention or graduation rates to be impacted. Rather, expect our students to strive to achieve the minimum grade of C, and be retained at the same rate or higher as is currently the case in the HEB major.”
 - Of the students that retook the course one time and two times, how did they perform on the additional attempts? [We currently do not keep records of the multiple attempts. We can proceed forward with a plan of keeping records by reviewing the HSC3032 roster at the end of the term (proactive check) to see if any students will possibly need to repeat a course. Additionally, we can capture information of students that are not meeting the HSC GPA through the following forms: HSC4800 Pre-Internship Clearance Survey, HSC4876 Internship Clearance Survey, and the HHP General Petition, email, 10/10/22]
 - Course attempt policy
 1. Students shall have no more than two attempts to complete a HEB required course.

2. After two attempts with a grade of C- or lower, the student will be encouraged to explore other majors (will be dismissed from HEB). Note: Students have the option to meet with members of the Department Petitions Committee to petition this policy.
 - a. The phrasing of this will need to be adjusted. Can students petition the dismissal or the policy? [We can change to “Students have the option to meet with members of the Department Petitions Committee to petition the dismissal”]
 - b. Recommend clarifying the “encouraged” v “dismissal” [We can change the word to ‘advised’. Advised in the process of exploring other majors (keeping the student on-track with the university’s graduation requirements).]

 - GEO 4169 has a prereq of GEO 4167C-3credits (not listed in request) which also a prereq of GEO 3162C –4 credits (not listed in request).
 - LAS 4953 does not appear in course catalog and appears to be a Latin American Studies prefix.

Proposed Israel Studies Certificate in the College of Liberal Arts and Sciences [R][CA]

 - Proposed 15 credit hour Israel Studies certificate in the Center for Jewish Studies programs.
- Comments:

- There are a large number of courses for this certificate that are not permanent courses. Course requests for permanent course numbers must be submitted before this request may be approved. [Almost all Jewish Studies courses are JST 3930 or 4931 courses. This has always been the case and is the case for all certificates and degrees in the Center. It is so because Jewish Studies is a Center and not a Department, nor an FTE home, not a tenure home for most faculty. We are the Center for Jewish Studies, not a Department. Achieving permanent course numbers is complicated for a Center and more difficult to achieve approvals. We have not been asked to do so in the past for our degrees or certificates. Email, 10/13/22]
- What are the objectives for this certificate that differ from the Jewish Studies Certificate and the Hebrew Minor/Major?
 - "Students who complete the following courses and take language courses, or additional topical courses in Jewish Studies, may also meet the requirements for the minor or major degree." [The certificate is thematically specific to Israel Studies. It is a cross-disciplinary certificate within Jewish Studies focused on humanities and social science topics in Israel, per se (including religions in Israel, history, society, culture, law, media, literature, and other topics).
The minor is not specific to Israel. It is a broader Jewish Studies minor crossing topics in Jewish history, Judaica, Bible, religion, literature, culture, politics, law, media, etc., related to Judaism, globally, in the U.S. and elsewhere.]
- CPO 4401 does not appear in the course catalog. [It should not have been removed and I am not sure who removed it from the curriculum.]
- LLC 3930 does not appear in the course catalog. [We will change it. It is intended to indicate a special topics offering in LLC. Because we are a Center and not a Department, most of our courses are listed in the registrar as special topics courses. The "JST" prefix indicates that it is a course offering from the Center for Jewish Studies. We are not a Department.]
- Please clarify what “most conditions are”: The total number of required credit hours for the Certificate in Israel Studies is 15, or, under most conditions, 5 courses.”
 - What are the exceptions? [The exception is if a course is offered for fewer than 3 credits. It is rare, we are instituting a study abroad program in Tel Aviv this summer which has been approved by the International Center. Not sure if that will be three hours in all cases. Also, we offer 1 hour courses through the Honors Program

such as Uncommon Reads. In the spring it will be a course on A.B. Yehoshua, which could count for this certificate.]

- **Rationale:** Our goal is to ensure success in ACG 3101, especially for accounting and finance majors and accounting minors, who are all required to take the course and earn a C or better in order to advance to the next course, ACG 4111. In order to succeed in ACG 3101, students need to first understand certain fundamentals of accounting. Although these topics are taught in introductory courses, the pedagogy and credit hours vary from school to school. Students who take the introductory courses outside UF perform significantly worse in ACG 3101 on average than those who take them at UF (see attached analysis). This disparity negatively impacts first-time-in-college students who elect to take the courses as transient students, but also by definition negatively impacts our transfer population, many of whom find it difficult, if not impossible, to succeed in the accounting major.
