 - Add additional course sequence to satisfy requirements for degree:
 - One semester of either MAA 4102 or MAA 4211.
 - One semester of any of MAA 4103, MAA 4212, or MAA 4402
 - The following restriction still applies:
 - If MAA 4402 is used to satisfy this requirement, then MAA4402 (or MAA5404) may not also be used to satisfy the mathematics elective requirement.
- Comments:
 - ~~On catalog copy, under coursework for the major, why is MAS 4105 listed? Please remove or clarify.~~ [MAS4105 is a required course for both tracks (BA and BS) and it should remain in the catalog. (We did not ask to remove it). This is the link to the 2022-2023 catalog copy https://catalog.ufl.edu/UGRD/colleges-schools/UGLAS/MAT_BA_BS/MAT_BA/ It lists MAS4105 as a required course and we want to keep it as required. Email response, 1/13/23].
 - Note: I think the original question from the Review SC was curious about why “MAS4105” was included in the catalog copy revision submitted for this request:

‘A minimum of 39 credits of mathematics and mathematics-approved electives is required for each degree. All coursework for the major must be completed with minimum grades of C.MAS 4105’

This must have been a typo!

- Please clarify the footnotes in the required course list and the desired course options for students. The current phrasing and requirements are not clear. What is the desired outcome for students?

[Footnote 3: “If this option is selected, then MAA 4402 (or MAA 5404) cannot be used to satisfy the mathematics elective requirement”.

Clarification: This footnote is already in the 2022-2023 catalog (approved by the UCC last year). MAA4402/MAA5404 is a combined undergraduate/graduate course that is an approved math elective. If students select to take MAA4402 to fulfill the “Additional Required coursework”, then the course cannot count towards the “four approved math elective requirements.”

Footnote 1 “ Students must earn a minimum grade of B in MAS 4105 before taking MAA 4211.”

Clarification: The prerequisite for MAA4211 is a minimum grade of B in MAS4105 and we wanted to emphasize that.

Footnote 2 “Students must complete MAA4211 with a minimum grade of C before taking MAA4212”

Clarification: We want to emphasize that the course prerequisites will be enforced. For example, if a student selects MAA4102 to fulfill the first 3 credits, then they cannot take MAA4212 for the other 3 required credits. Their only options will be either MAA4103 or MAA4402.

Clarification of course options: Under the 2022-2023 curriculum (pasted below) students may select one of the following sequences to fulfill the additional required coursework requirement for the B.A. degree:

Please note that there is a typo in the last sequence in the current catalog copy: The approved (by the UCC) sequence is MAA4211 & MAA4402 (not “MAA4211 or MAA4402”). I have sent the catalog edit/correction request to the CLAS advising office.

We are proposing adding a 5th sequence: MAA4102 & MAA4402 to satisfy this requirement.

Hence under the proposed curriculum change, the additional coursework requirement for the B.A. degree can be satisfied by:

- o One semester of either MAA 4102 or MAA 4211.
- o One semester of any of MAA 4103, MAA 4212, or MAA 4402

The restriction (footnote 1 in the current catalog copy) still applies: If MAA 4402 is used to satisfy this requirement, then it (or MAA 5404) may not be used to satisfy the mathematics elective requirement. The other footnotes emphasize that prerequisites are enforced.

- Note: I think what made this more confusing than it should have been is that the approval form request listed only 4102/4103, 4211/4103, 4211/4402 as current options for additional required coursework. The 4211/4212 was not included, as shown in the current catalog with 4102/4103, 4211/4402. Also, 4211/4103 is not shown in the current catalog. This compounded the confusion! This request will approve the above options for Additional Required Coursework for the B.A. in Mathematics.
 - Currently the additional coursework for the B. A. degree can be satisfied by one of the following
 - sequences: (MAA4102 and MAA4103) or (MAA4211 and MAA4103) or (MAA4211 and MAA4402). Under the proposed change, students can also select the sequence MAA4102 & MAA4402 to satisfy this requirement.

 - Additionally, the following note is to be added to Additional Required Coursework:
 - If MAA 4402 is used to satisfy this requirement, then it may not also be used to satisfy the mathematics elective requirement.
 - Remove MAS 4105 with a minimum grade of B from the BS degree and the critical tracking requirements. Under the proposed change, MAS4105 must be completed with a minimum grade of C.
 - Remove “MAC 2512 Calculus 2 for Advanced Placement Students” from the coursework for the B. S. degree. MAC 2512 is a course that we are no longer offering (and have not offered for many years); it served as a substitute course for MAC2312.

 - Course changes previously approved.
 - Please clarify the footnotes in the required course list and the desired course options for students. The current phrasing and requirements are not clear. What is the desired outcome for students?

[We are requesting that students in the BS track have the same flexibility as students in the BA track in the selection of the courses to fulfill the additional required coursework requirement.

We are proposing allowing the same 5 sequences as for the BA track to satisfy this requirement for the BS track. Hence under the proposed curriculum change, the additional coursework requirement for the B.S. degree can be satisfied by:

- One semester of either MAA 4102 or MAA 4211.
- One semester of any of MAA 4103, MAA 4212, or MAA 4402

The restriction (footnote 1 in the 2022-2023 catalog copy) still applies: Students must earn a minimum grade of B in MAS 4105 before taking MAA 4211. Since we are including MAA4102 and MAA4402 in the course options, we have added the same footnotes as in the BA changes to emphasize that prerequisites will be enforced (so the combination MAA4102& MAA4212 will not be possible).

This would result in six possible combinations, including 4102 and 4212, which is not listed directly above.

- This request also asks to remove MAC2512 from the catalog as Required Coursework because the department has not offered this course for some time nor intends to offer it. Will the department request that the Registrar terminate the course from our course records?

It can be gleaned from the brief rationale for this request that the replacement courses are more strongly rooted in biological and archaeology subfields whereas the two courses requested for removal are not rooted in one of the scientific subfields. Is this correct?

- Comments:
 - ~~Please rename request to full title of program~~
 - Semester 6 credit hours do not add correctly (total of 119) [Updated, 1/10/23]
 - Please upload a single tracked changes document for catalog copy, without comments.
 - [Requested changes are still not clear in the form or the tracked changes catalog (still original document).
 - List of courses being removed is not included in form or catalog copy tracked changes document.
 - Catalog copy does not include minimum grade of C statement. – CG, 1/13/23]
 - Please revise phrasing:
 - “Students must earn minimum grades of C, attained within two attempts (including withdrawals), are required in major core courses. Students must maintain a 2.5 or higher GPA on all critical-tracking courses. A 2.0 cumulative GPA is also required to successfully complete the degree.”
 - Recommend replacing with “Students must earn a minimum grade of C within two attempts in all required core courses.”
 - Please give a more detailed explanation for the rationale for this change. What are the benefits for student learning by increasing the GPA requirement for these selected core courses? What was the rationale for selecting these specific courses?
 - What are the anticipated impacts of this GPA requirement change on the overall student population and specific groups of students? For example, using historical data, how many students would not have

- progressed to degree because of the more stringent requirements?
Would this change impact diversity of your graduates?
- The current wording for the 2.5 or higher GPA requirement is “2.5 GPA on required math and science courses combined.” Is the requested language above changing the current requirement in Semesters 1-5? Could the program specify how the “Critical Tracking” tab by semester will change from the below?

The current prerequisite is JOU 3101 which teaches students print style writing and reporting. JOU 3101 acted as a “catch all” prerequisite for all upper division JOU courses. This does not make sense for broadcast courses because the style of writing between print and broadcast is vastly different. JOU 2100 is a more appropriate prerequisite because that class introduces students to broadcast style writing, broadcast vocabulary words, and broadcast writing on deadlines.
