### 1) UF Faculty Senate ad hoc Committee on Academic Freedom

We formed a special *ad hoc* committee on Academic Freedom. The charge of this special *ad hoc* committee is to gather information and report back to the Faculty Senate on UF practices that affect the ability of UF faculty to engage in outside activities that are normally accepted as appropriate scholarly activities of university faculty. This includes, but is not limited to, expert witness engagement, writing of op ed pieces, and consulting.

This special Senate Committee is separate from the President's Task Force on Expert Witness engagements. The Senate committee will consider outside activities of faculty in a broader context to reflect the range of concerns over academic freedom that we are hearing from faculty across the campus.

### 2) UF Faculty Senate ad hoc Committee on the Dr. Ladapo Hiring Process

We formed a special *ad hoc* committee on Academic Freedom. The charge of this special ad hoc committee is to gather information and report to the Faculty Senate on whether hiring practices used in the hiring of Dr. Joseph Ladapo into the Department of Medicine in the UF College of Medicine were inconsistent with practices used in the College of Medicine to hire other clinical faculty. As you probably are aware from the press attention that this hiring has received, Dr. Ladapo has also been nominated to be Florida's Surgeon General. There have been allegations in the press that Dr. Ladapo's hiring was accelerated and did not receive the normal faculty input that similar hires receive and the goal of this committee is to shed light on this question in an open and transparent manner.
