4.040. Student Honor Code and Student Conduct Code.

This proposed regulation amendment aligns UF policy with current federal law reflected in changes to BOG regulations 1.001 and 6.0105. It further clarifies the language for student readers and includes other substantive changes including:

- Incorporating F.S. 1004.097, Free Expression on Campus including:
 - Aligning procedures concerning disciplinary proceedings including:
 - Increased timelines, generally providing more notice to accused students;
 - An express presumption of innocence; and
 - A right to a complete record of any disciplinary proceeding.

4.040. Student Honor Code and Student Conduct Code Cont'd

Defining Class lecture as:

An educational presentation delivered by Faculty or guest lecturer, as part of a University of Florida course, intended to inform or teach enrolled students about a particular subject. Class Lecture does not include lab sessions, student presentations, clinical presentations such as patient history, academic exercises involving student participation, assessments (quizzes, test, exams), field trips, private conversations between Students in the class or between a Student and the Faculty or guest lecturer during a class session.

Placing restrictions on unauthorized recordings or publishing lecture materials:

Students may make a Recording of a Class Lectures for three (3) lawful reasons: for their own personal educational use, in connection with a complaint to the University, or as evidence in or preparation for a criminal or civil proceeding. A Recorded Class Lecture may not be Published without the prior express written consent of the Faculty or guest lecturer.

1.300. Direct Support Organizations, Health Services Support Organizations

Updates the language to meet the current legislative and BOG requirements for direct support organizations and health services support organizations.

Primarily, how Board members are appointed.
